

CashBack Scheme KUMA Music School School Year 2023-2024 (verbeterde versie 5 sept 2023)

KUMA Music School wants to stimulate students who follow lessons with teachers who are (prospective) members of KUMA with a contribution to the tuition fee. This allowance or CashBack is paid directly to the tuition fee by KUMA music school until the available amount has been reached. There is a ceiling. Gone=gone

1. The CashBack applies to all students of teachers who are (prospective) members of KUMA music school, who meet the conditions.

The amount of the subsidy is as follows:

Group lesson adult	Minimum 20 clock hours (1200 minutes) lesson at Centre Céramique	€ 35,-

- 2. The student is only eligible for the age category under 18 if he or she is not yet 18 years old at the time of registration. Students who are 18 years old at the time of application and want to count as a 17-year-old must send proof of registration.
- 3. Applications can be made by filling in the application form. This form must be signed by both the person who paid the tuition fee (the student, his parents / guardians / guardian / administrator) and the person who received the tuition fee (the teacher).
- 4. Applicants who submit an application between 1 September and 30 September 2023 and who meet the set conditions are certain that they will receive an allowance. The applicant must submit the application form in the physical mailbox at the music school in the basement of Centre Ceramique. This year we ask the teachers to collect the forms in the first weeks and then put them bundled (in envelope or folder) in the mailbox no later than September 30. KUMA will ask the teacher for a confirmation of the relevant application by e-mail. For the purpose of processing, it is therefore important that the teacher emails the confirmation as soon as possible.

- 5. Applications received from 1 October will be processed in order of arrival. KUMA will ask the teacher for a confirmation of the relevant application by e-mail. The answers of teachers determine the order of final treatment. The following applies: op=op. It is therefore important that the teacher emails the confirmation as soon as possible. An application that could not be granted for this reason will not be given priority in the following year. The deadline for submitting an application will be 31 May 2024.
- 6. Students who follow more than 1 course/course in school year 2023-2024 will apply for CashBack separately for each course/course. They cannot apply 2 times for the same course/course.
- 7. Students who stop the lessons in the meantime, for which KUMA Music School has paid out on the basis of the CashBack are not obliged to refund the CashBack to KUMA Music School.
- 8. The teacher, who signs the form, is obliged to pay the minimum number of clock hours rent for which the student receives the CashBack to Vereniging KUMA, even if the student stops the lessons in the meantime. This rented time may be filled in with students who have not applied for/cannot apply for CashBack.
- 9. The conditions to be met:
 - 1. A fully completed form (incomplete forms will not be processed) with a signature of both the (parent / guardian of) the student and the teacher.
 - 2. Comply with the minimum number of clock hours mentioned under point 1
 - 3. Comply with the obligation that the lessons take place at Centre Ceramique
- 10. The applicant agrees that a scan of the application form will be forwarded to the processor of the form (a member/board member of KUMA or a hired third party for the administrative processing of the CashBack scheme), the accountant for audit and the municipality of Maastricht for the burden of proof of the subsidy that the KUMA association receives.
 The application form will be destroyed after 1 year after the end of the school year for which the application is made.

11. Payout if you do qualify:

Payout CashBack: after application, the amount will be deposited within 3 months if the applicant meets the set conditions and the ceiling has not yet been reached. You will not receive a message about the payout. (if payment obligation does not need to be checked)

12. Notification if you are not eligible or the ceiling has been reached

If you are not eligible because you do not meet the conditions, or if the financial ceiling has been reached, you will receive an email that you will not receive CashBack.
