- The maximum amount of compensation is:

 - Cashback G: € 130.00
- If the required number of minutes for individual lessons is not met, the compensation will be applied proportionally, with a minimum of 120 minutes (two clock hours).

Conditions

- The cashback-policy applies to all students of teachers who are (aspiring) members of KUMA Muziekschool.
- Students are eligible for the full cashback if:
 - They meet the minimum required number of minutes. The minimum for individual lessons is 600 minutes; the minimum for group lessons is 1,000 minutes. For group lessons for children under 10 under Cashback E (only the *Muziekmakers* course or the *Oriëntatiecursus Muziek*), the minimum is 450 minutes per course.
 - They meet the requirement that lessons take place at Centre Céramique. An exception applies to lessons organized by KUMA Muziekschool in cooperation with external (social) partners.
 - The available budget has not yet been exhausted.

Age category

- A student is only eligible for the applicable age category if he or she has not exceeded the maximum age on June 15, 2026.

¹ An exception applies when the Cashback is combined with with Jeugd-/Volwassenenfonds Sport & Cultuur.

Application Process

6. Application must be submitted using the fully completed application form, including all required documents/attachments. The form must be signed by both the tuition payer (the student, their parents/guardians/trustee) and the teacher receiving the tuition fee.
Incomplete forms will be not handled.
7. Applicants must submit the application form in the physical mailbox of KUMA Muziekschool, located in the basement of Centre Céramique.
8. Applications can be submitted from **October 1, 2026, to May 31, 2027**, and will be processed in order of receipt.
9. Students enrolled in more than one course/subject in the 2026-2027 school year can apply separately for each course/subject but cannot apply twice for the same course/subject.
10. KUMA will request email confirmation from the teacher regarding the application. The order of processing is determined by the teacher's response time. Since the budget is limited, teachers must confirm as soon as possible. If an application is denied due to budget exhaustion, it will not be given priority in the following year. The final deadline for applications is May 31, 2027.

Payment

11. If an application is approved and the budget has not been fully allocated, the respective amount will be transferred within three months. Applicants will not receive a notification regarding payment.
12. If the applicant is ineligible or if the budget cap has been reached, they will receive an email notification.

Termination of Lessons

13. Students who discontinue lessons for which they received a Cashback from KUMA are not required to repay the received amount.

Data Processing

14. Applicants agree that a scanned copy of the application form may be forwarded to the processor (a member/board member of KUMA or a third party hired for administrative processing of the Cashback Policy), the accountant for auditing, and (if necessary) the Municipality of Maastricht as proof of the subsidy received by KUMA Maastricht. The application form will be stored by KUMA for the legally required retention period. After that, it will be deleted.

3. Print the form and sign it.

4. Attach a copy of an ID document (ID card or passport).
 - Blur your citizen service number (BSN) on the copy, including the number series at the bottom.
 - Write on the copy that it is a copy.
 - Specify that the copy is for KUMA Music School.

5. Give the form to your teacher.
6. After verification, the teacher will sign the form.
7. Submit the form in the mailbox of KUMA in the basement of Centre Céramique.
